Capital Markets Union

The Council adopted a regulation improving the existing regulatory framework applying to the overthe-counter (OTC) derivative market. The regulation, which will amend the European Market Infrastructure Regulation (EMIR) in order to address disproportionate compliance costs, transparency issues and insufficient access to clearing for certain counterparties, will enter into force 20 days after its publication in the Official Journal of the EU.

Banking Union

The Council adopted a comprehensive legislative package which contains amendments to the Capital

Requirement legislation (Regulation 575/2013 and Directive 2013/36/EU) and the framework for the recovery and resolution of banks in difficulty (Directive 2014/59/EU and Regulation 806/2014). The package will enter into force 30 days after its publication in the Official Journal of the EU. Most of the new rules will start applying in mid-2021 with the goal to reduce risks in the sector.

■■ Connected Vehicles

The Council decided to extend the time-limit for raising objections to the Commission Delegated Regulation relating to the deployment and operational use of cooperative intelligent transport systems by two months, until 13 July. At the Council Working

Party on Transport some delegations expressed concerns of a legal and technological nature on the regulation; therefore the Presidency asked the Council Legal Service for an opinion.

■ Energy Charter Treaty

The EC adopted a recommendation to negotiate on behalf of the EU the modernization of the investment provisions of the Energy Charter Treaty, the plurilateral trade and investment agreement applicable to the energy sector.

■ Data on New Trucks

The Council decided not to object to a Commission Regulation concerning the monitoring and reporting of data on new heavy-duty vehicles by Member States and Manufacturers.

The EC adopted the Implementing Decision to harmonize the 26 GHz frequency band for wireless networks, which must be completed by the end of March 2020.

■ Generic Pharmaceuticals Producers

The Council adopted a regulation which introduces an exception to the protection granted to an original medicine by a supplementary protection certificate (SPC) for export purposes and/or for stockpiling. The regulation shall enter into force by 1 July and it will enable generics manufacturers based in the EU to compete with non-EU manufacturers on equal terms.

■ State Aid for Environmental Protection and Energy

The EC launched a public consultation on the evaluation of the guidelines on State aid for Environmental protection and Energy (EEAG) and the provisions applicable to aid for environmental protection and energy of the General Block Exemption Regulation.
