#### ■ Covid-19 and Export Scheme

The EC published a new export authorisation scheme for personal protective equipment, reducing the list of products that require export authorisation to masks, spectacles and protective garments, extending the geographical exception and requiring Member States to swiftly grant authorisations in case of humanitarian purposes. The measures remain temporary.

#### EC Implementing Regulation 2020/568

#### **■ Medical Devices Regulation**

The proposal to postpone by one year the date of application of the Medical Devices Regulation has been adopted. The regulation will amend Directive 2001/83/EC, Regulation 178/2002 and Regulation 1223/2009 and repeal Council Directives 90/385/EEC and 93/42/EEC.

#### Regulation on medical devices

#### ■ Covid-19 and Agri-food Sector

The EC proposed additional exceptional measures to further support agricultural and food markets most affected during this crisis. In particular, the package includes measures for:

- private storage aid for dairy and meat;
- flexibility for market support programs;
- exceptional derogation from EU competition rules: applicable to the milk, flowers and potatoes sectors. The Commission aims to have these measures adopted by the end of the month.

Due to the current crisis, the European Commission is rescheduling its agenda and shall present an updated work program for the current year by the end of the month. Several initiatives will be delayed of up to one year.

#### **■** Brexit

EU negotiators remain positive regarding the possibility of achieving by June tangible progress on the negotiations with the UK regarding the new shape

of the relationship between the two parties. Next round of talks is scheduled for 11 May.

The European Commission will release at the end of the year a new pharmaceutical strategy, which will contain also a proposal that aims to increase the production of life-saving medicines in Europe.
