■ Carbon Border Levy

The European Parliament adopted a resolution on a WTO-compatible EU carbon border adjustment mechanism. The new mechanism involves all imports of products and commodities covered by the EU Emissions Trading System. The Commission shall present a legislative proposal on a carbon border adjustment mechanism in the second quarter of the year.
