## / Law

### ■■ Privacy and Electronic Communications

The Committee of Permanent Representatives of Member States agreed on a negotiating mandate for a proposal to revise the rules on the protection of privacy in electronic communications. The regulation will cover electronic communications content transmitted using publicly available services and networks, and metadata related communication. Inter-institutional negotiations with the European Parliament on the final text can now start. The draft regulation will repeal the existing rules, Directive 2002/58/EC, and will complement the General Data Protection Regulation. The new regulation would enter into force 20 days after its publication in the EU Official Journal, and would start to apply two years later.

### ■ Carbon Border Levy

The Environment Committee of the European Parliament adopted its own-initiative report on the creation of a so-called carbon border adjustment mechanism no later than 2023. The carbon border adjustment mechanism should cover all imports and should be linked to a reformed emissions trading scheme. The Parliament is expected to vote on the resolution during the plenary session in March. The Commission plans to present its legislative proposal on the mechanism in June.

The European Data Protection Supervisor released its opinions on the Commission's proposals for a Digital Services Act and a Digital Markets Act. On the DSA, the Supervisor recommends additional measures to better protect individuals regarding content moderation, online targeted advertising and recommender systems used by online platforms. On the DMA, the Supervisor calls for the introduction of explicit obligations on minimum interoperability requirements for Big Tech platforms.
