### ■ State Aid – RDI Framework

The EC launched a public consultation on the revision of the State aid Framework for research, development and innovation (the “RDI Framework”). Contributions can be submitted until 3 June. The proposed revision aims at aligning the framework to the new strategic priorities, such as the European Green Deal and the Digital Strategy. More specifically, the targeted adjustments consist in improving and updating the existing definitions, introducing new provisions to enable public support for technology infrastructures and simplifying certain rules. The adoption of the new framework is foreseen for the second half of the year.
