Brexit

The EC released its recommendation to the Council to open negotiations with the UK. EU Member States will have to adopt the draft directives, formally authorising the Commission to start the talks. According to the EU chief negotiator, Michel Barnier, the European institutions intend to negotiate a highly ambitious trade deal with zero tariffs and quotas on all goods. The agreement on the future relationship will have to be concluded before December, when the transition period will expire. However, this period can be extended once for one to two years, but the decision must be taken by the EU-UK Joint Committee before 1 July.

Review Fiscal Rules

The EC launched the review of the economic surveillance framework, in order to ensure sustainable government finances and economic growth, enable closer coordination of economic policies and promote convergence among Member States. As part of this exercise, the Commission also invited interested parties to give their feedback. The review should be completed by the end of the year.

Competition and Digital Sector

The Ministers of Economy of Germany, France, Italy and Poland in a joint letter to the European Commission called on the European executive to adopt a work plan with practical proposals in the coming weeks in order to update the rules on competition and make them more efficient and effective. In particular they suggest to put in place a framework for the definition and regulation of digital platforms and to review the guidelines of merger control.

The European Commission is already working on measures to strengthen and adapt competition rules to the evolving digital world. In the coming days it shall present some working documents; while it will take a bit longer for the launch of a sector inquiry in the field. A specific schedule of the review is not clear yet, however this is a work in progress with different initiatives throughout the year and a comprehensive Digital Services Act expected for the end of 2020.
