■■ Impact of Digitisation on Competition

The EC released the report "Competition policy for the digital era" of the three Special Advisers on the impact of digitisation on competition policy. In particular, the report identifies the main challenges posed by dominant tech players. The issue whether competition rules should be changed and refined to adapt to digital markets and data economy is central. The Commission invites regulators to discuss the findings of the report.

Open Data Directive

The European Parliament approved the Open Data and Public Sector Information Directive, which aims at improving the availability and innovative use of public and public-ly-funded data, useful also for the development of data-intensive technologies such as artificial intelligence. The Council now needs to formally adopt the directive. Mem-

ber States will then have two years to implement the new rules.

Natural Gas Market

The European Parliament voted in favour of the proposal for a directive on common rules for the internal market in natural gas. The proposal seeks to apply key provisions of the Gas Directive of 2009 to gas pipelines between the EU and third countries. The text now needs to be formally adopted by the Council. Member States will then have nine months to transpose the revised rules into national laws.

■ WTO Cases

The EU launched two disputes in the World Trade Organisation against India, for unlawful import duties on ICT products, and Turkey for unlawful measures on pharmaceuticals.
