■ Future of Europe

At the informal Summit in Romania dedicated to the future of the EU, the Heads of State and Government of the 27 Member States signed the so-called Sibiu Declaration, which contains ten commitments for next five years.

The document is based on the Commission's Communication and will be used to set the strategic agenda for the years 2019-2024. In the coming years the EU institutions intend to focus on empowering and protecting citizens; freedom and security; competitiveness and growth; energy and climate policies and the international dimension of the EU.

■ **EU-US Trade**

EU Commissioner for Agriculture confirmed that agriculture is not on the agenda of the EU-US talks for a trade agreement. This is contrary to what the US intends to achieve: a deal that includes a chapter on agriculture.

■ ■ **Connected Vehicles**

The scrutiny period for the Council Working Party on Transport will end on 13 May. EU experts will have to decide whether to object or not to the Commission Delegated Regulation on the deployment and operational use of cooperative intelligent transport systems. Discussions on the Delegated Regulation are still going-on at the European Parliament.
