■ General Block Exemption Regulation

The EC launched a targeted review of the General Block Exemption Regulation, in order to extend its application to national funds involved in some specific areas (research, development & innovation; financing and investment operations; European territorial cooperation) under a limited set of conditions. Contributions can be submitted until 27 September. The Commission aims to adopt the final text in time for the next Multiannual Financial Framework.

■ Energy Union

The Council adopted its conclusions on the future of energy systems in the EU. The document identifies a set of priorities for future policy-making aimed at

ensuring the energy transition towards a competitive, secure and sustainable energy system.

■ Artificial Intelligence

The High-level Expert Group on Artificial Intelligence, the independent group set by the European Commission in June 2018, released its policy and investment recommendations for trustworthy AI, which are addressed to EU Institutions and Member States.

The Council adopted a political guidance on the development of a sustainable EU chemicals policy strategy, addressing in particular the topics of REACH,

endocrine disruptors, nanomaterials and pharmaceuticals.

The EC released its findings of the fitness check of the most relevant chemicals legislation, with the exclusion of REACH.

■ REACH

The EC presented an action plan to address the lack of compliance in registration dossiers. In particular it contains a proposal to amend REACH in order to raise the current 5% minimum target for compliance checks to 20% of registration dossiers in each tonnage band. The proposal is expected to be adopted by the end of the year.

■ Crowdfunding Platforms

The Council adopted its position on two proposals that aim at harmonizing the minimum requirements on crowd-funding platforms and on investor protection rules. The two proposals will set out a new regulatory framework for the operation of these platforms. The European Parliament adopted its position last March;

therefore the co-legislators can now start inter-institutional negotiations on the texts.

■ EU-Vietnam Trade Agreement

The Council approved the EU-Vietnam Trade and Investment Agreements, paving the way for their conclusion. Most likely this Sunday EU Commissioner for Trade will sign the trade agreement, which will eliminate nearly all customs duties on goods and remove technical obstacles, such as those in the car sector. Next step is the vote by the European Parliament. Once the lawmakers have given their consent, the trade agreement can be officially concluded and enter into force, while the investment protection agreement still needs to be ratified by Member States.

■ Vertical Block Exemption Regulation

Before the Summer break, the European Commission is expected to publish the summary of the contributions received to its public consultation on the current Vertical Block Exemption Regulation, which expires on 31 May 2022. The European executive will have to decide whether to let the regulation end, prolong or revise it.

■ Energy Work Programme

Finland will take over the Council Presidency on 1 July. The programme of the country for the next six months focuses in particular on finding an agreement on an EU commitment to climate neutrality. Investments in the green transition and in the development of innovative technologies have a major role to play according to the country.
