#### **LAW**

#### Cross-border eCommerce

Negotiators of the Council and the European Parliament agreed on a compromise on a directive on contracts for the supply of digital content and services and a directive on contracts for the online sales of goods. This provisional agreement will now have to be confirmed by the two institutions. Following final adoption, the directives will be published in the EU Official Journal and enter into force 20 days later. The agreed texts will be available soon.

# EU Energy Efficiency

The Committee of Permanent Representatives endorsed the technical adjustment in the newly revised energy efficiency directive to take account of the UK withdrawal from the EU. The text endorsed is the same as the one adopted by the European Parliament, therefore no negotiations between the co-legislators will be necessary, if the EP confirms its position in plenary. Both the EP and the Council are expected to adopt the decision before the end of March.

# ■■ Competition Enforcement in the Pharma Sector

The EC adopted its report on competition enforcement in the pharmaceutical sector. The report, "European competition authorities working together for affordable and innovative medicines", provides an overview on the enforcement at EU and national level of antitrust and merger rules in the pharma sector.

The EC published the regulation that imposes definitive safeguard measures against imports of certain steel products, replacing the provisional measures of last July.

#### Cross-border Mobility of Companies

The Committee of Permanent Representatives agreed on the Council's position on the draft directive on crossborder conversions, mergers and divisions of companies. The Presidency will now start negotiations with the EP with the aim of adopting the draft directive at first reading.

The Committee of Permanent Representatives adopted the Council's position on the directive on the protection of whistle-blowers. Inter-institutional negotiations with the European Parliament can now start. The adopted text will be available soon.

# Capacity Calculation Regions

# Microplastics

The European Chemicals Agency (ECHA) adopted an opinion on restricting micro-plastics intentionally added to products, covering a variety of sectors from cosmetic industry to agriculture and construction. The opinion will now be scrutinised by ECHA Committees and there will be also a 6-month public consultation. Afterwards, the ECHA Committees will submit their final opinion to the EC, not before Spring next year.
