#### **■ Climate Law**

The EC presented its proposal for a regulation establishing the framework for achieving climate neutrality and amending Regulation 2018/1999, the so-called European Climate Law, that aims to review and complement the existing framework in view of the long-term climate neutrality objective.

The Commission will first assess existing policies, then it will make proposals for increasing the greenhouse gas emission reduction target for 2030 in order to comply with the commitment to be climate neutral by 2050. By September this year, the European executive will present an impact assessment plan to increase the 2030 target; by June 2021 it will propose reviews of the European Emissions Trading System Directive; Effort Sharing Regulation; Energy Efficiency Directive; Renewable Energy Directive; Land use, land use change and forestry Regulation; CO2 emissions

performance standards for cars and vans. Then, by September 2023 (and every five years thereafter) the Commission will assess the consistency of EU and national measures with the climate-neutrality objective.

#### **■ Carbon Border Tax**

The European Commission invited this week interested parties to submit feedback on the inception impact assessment of its proposal for a directive on Carbon Border Adjustment Mechanism for selected sectors. Among Member States there are different views regarding such proposal. This is a delicate issue with implications also related to which sectors shall be included. Therefore, it seems likely that a final proposal will not be ready before 2021.

#### ■ Brexit

After the first round of negotiations on the future trade relationship the positions of the two sides are pretty different. The UK aims to conclude sectoral agreements on a case-by-case basis, while the EU wants first to negotiate a global framework on all governance issues. Next meeting is scheduled for the end of the month.
