# **■ EU Industrial Strategy**

The EC presented its Industrial Strategy, a package of initiatives that aims to realize the digital and green transition together with supporting global competitiveness. Alongside this package of measures, the Commission adopted also a dedicated strategy for small and medium-sized enterprises.

Among the actions foreseen by the strategy there are:

- launch of an Intellectual Property Action Plan;
- strengthening of the global rules on industrial subsidies in the WTO;
- adoption of the International Procurement Instrument;
- modernization and de-carbonization of energy-intensive industries;
- a common European Energy Data Space;
- launch of an EU-wide hydrogen alliance;

- action plan on crucial raw materials;
- investment in research and deployment of technology in artificial intelligence, 5G, data analytics;
- a new pharmaceutical strategy for the EU;
- further legislation and guidance on green public procurement;
- action plan on the customs union, to reinforce customs controls.

My mid-2020 the Commission will adopt a White Paper to address the distortive effects caused by foreign subsidies in the single market and to tackle foreign access of state-owned companies to EU public procurement. In addition to that, in 2021 the European executive will present a proposal to further strengthen the framework for the screening of foreign direct investment.

With regard to European competition rules, the Commission will continue the ongoing review, including the evaluation of merger control and fitness

check of State aid guidelines. If necessary, the Commission will present a proposal to adapt the European rules in 2021. The European executive already announced that it will present next year revised state aid rules for Important Projects of Common European Interest (IPCEI).

An inclusive Industrial Forum will be set up in the coming months and it will support the Commission to analyze the risks and needs of the different sectors, in order to present more targeted measures.

### Circular Economy

The EC presented its new Circular Economy Action Plan, as part of the EU Green Deal. The plan contains a series of initiatives, legislative and non-legislative measures, for the entire life cycle of products. In particular, it includes a revision of EU waste legislation, with new targets to reduce packaging waste and mandatory essential requirements for all packaging; a circular electronics initiative; new rules on the collection and recycling rates of batteries; a revision of the industrial emissions directive.

# European Champions

Among EU Member States the differences of view on the so-called European Champions issue remain high. Eight countries (including Sweden, the Netherlands, Finland and Ireland) sent a letter to Commissioner Vestager stressing the need that "any review of Europe's competition rules, including the review of State aid rules and guidance, is based on proven principles, evidence and economic research ...", underling that "any moves to soften and politicise EU

competition rules would be detrimental for the whole EU".

#### ■ Privacy and Electronic Communications

The Council Working Party on Telecommunications is still discussing the new proposals of the Presidency on the draft regulation concerning the respect for private life and the protection of personal data in electronic communications, which will repeal Directive 2002/58/EC. Next meeting is scheduled for 19 March.
