

■ Public Procurement Framework

The EC released practical guidance on how to use the flexibilities of the European public procurement framework in the current crisis.

EC guidance

Covid-19 and State Aid

The EC submitted to Member States for consultation a draft proposal to extend the State Aid Temporary Framework adopted on 19 March, by adding additional support for five types of aid measures:

- more support for coronavirus related research and development;
- more support for the construction and upgrading of testing facilities;
- more support for the production of products relevant to tackle the outbreak;

- targeted support in the form of deferral of tax payments and/or suspensions of employers' social security contributions;
- targeted support in the form of wage subsidies for employees.

The Commission aims to have the amended framework in place next week.

Temporary Framework for State Aid Measures

Antitrust

The EC launched a dedicated website to provide guidance to companies that intend to cooperate with each other during the coronavirus crisis. A dedicated mailbox has also been set up.

Covid-19 And Insurance

The EC decided to temporarily remove all countries from the list of "marketable risk" countries under the Short-term export-credit insurance Communication. The document will be published soon.

Airports and Slots

The proposal for a regulation that will amend to Regulation 95/93 allowing airlines to temporarily exempt from the obligation to use 80% of the slots for the period from 1 March 2020 until 24 October has been adopted. It will also apply retroactively from 23 January to 29 February 2020 for flights between the EU and China or Hong Kong. The Commission will monitor the situation and report back on it by 15 September.

■ Waste Shipments

The EC issued guidance for a common approach to secure the continuation of waste shipments across the EU in the exceptional circumstances of the coronavirus outbreak.

■ Covid-19 Funds

The Council adopted two legislative acts to release funding from the EU budget to tackle the current crisis.

The Coronavirus Response Investment Initiative will give Member States €37 billion to strengthen healthcare systems, support small and medium-sized enterprises, short-term working schemes, and community-based services. Member States will also

have more flexibility to transfer funding between cohesion policy programmes in order to redirect resources to where they are most needed.

■ EU-Vietnam Trade

The Council adopted a decision on the conclusion of a free trade agreement between the EU and Vietnam. The deal provides for the almost complete (99%) elimination of customs duties between the two blocks. Once the Vietnamese National Assembly ratifies it, the agreement can enter into force, most likely in early summer 2020.

■ Medical Supplies

The EC issued guidance to assist manufacturers in the production of essential medical equipment, in particular of masks and other personal protective equipment, leave-on hand cleaners and hand disinfectants and 3D printing in the context of the coronavirus outbreak. A guidance on medical devices will also be make available within the coming days.

During the teleconference between representatives of the EU and the UK, the two parties decided to launch the work of six Specialised Committees on the key areas for the implementation of the Withdrawal Agreement. The next meeting of the Joint Committee is currently foreseen for June.

According to the President of the European Commission the central element of the so-called Recovery Plan should be an updated long-term budget for 2021-2027. The plan should also be consistent with the green transition foreseen in the original agenda of the new Commission.
