■ Money Laundering

The EC presented an Action Plan for a comprehensive policy on preventing money laundering and terrorist financing which sets out concrete measures that the Commission will adopt in the next 12 months. The plan is built on six pillars: effective implementation of existing rules, a single EU rulebook, EU-level supervision, a support and cooperation mechanism for financial intelligence units, better use of information to enforce criminal law, a stronger EU in the world. Together with the communication, the Commission also adopted a new list of third countries with strategic deficiencies in their anti-money laundering counter-terrorist financing frameworks. Interested parties can provide their feedback until 29 July.

■ Covid-19 and Agri-food Sector

The EC adopted a package of measures to further support the agricultural and food sectors most affected by the coronavirus crisis. The measures include private storage aid for the dairy and meat sectors, the temporary authorisation to self-organise market measures by operators in hard hit sectors, and flexibility in the implementation of market support programmes.

Insolvency

The European Commission is evaluating a new mechanism to support companies at risk of insolvency, especially in vulnerable countries; the new instrument could be included in the updated proposal of the multi-annual financial framework that shall be released by the end of the month.

■ Digital Services Act and Competition

The European Commission is expected to present its Digital Services Act by the end of the year; the plan shall also include a new competition tool which aim to prevent the tipping of markets.

■ General Data Protection Regulation

The report on the application of the General Data Protection Regulation shall be released by the European Commission on 3 June.
