## / Law

### **■ Climate Target Plan**

In order to implement the 2030 Climate Target Plan, the EC published its inception impact assessments which contain suggestions on the nature and scope of the revisions of four pieces of European climate legislation: the EU Emissions Trading System; the Effort Sharing Regulation; the Regulation setting CO2 emission standards for cars and vans; and the Land Use, Land Use Change and Forestry Regulation. Feedback on the assessments can be submitted until 26 November. Further open consultations will follow. The proposals shall be adopted June next year.

#### ■ European Climate Law

The Council reached an agreement on a partial general approach on the European Climate Law, which aims to set the framework for achieving climate-neutrality by 2050, amending Regulation 2018/1999.

## ■ Vertical Block Exemption Regulation

The EC published its inception impact assessment on the revision of the Vertical Block Exemption Regulation. Feedback to the document can be submitted until 20 November. Proper consultation will start in the coming weeks.

#### State Aid Modernisation

The EC published the results of the evaluation of the EU State aid rules as part of the Commission's ongoing review and modernisation exercise. Overall the rules are fit for purpose, but some individual adjustments are needed in order to reflect recent developments and future challenges. The exercise covered among others the General Block Exemption Regulation, De minimis Regulation, Guidelines on State aid for environmental protection and energy and Guidelines on State aid to airports and airlines.

#### ■■ Digital Market

Commissioner Vestager during an hearing at the European Parliament's Internal Market Committee confirmed that the Digital Services Act (DSA) and the Digital Markets Act (DMA) will be released in December, most likely on 2. Answering to the lawmakers' questions Commissioner Vestager stated that the DMA will look into ex-ante prohibitions on digital gatekeepers and there will be an objective list of criteria to identify those in the scope of the new regulation. The DSA will instead focus on the accountability, responsibility and transparency of digital service providers.

#### ■ Money Laundering

The Finance Ministers of Member States are expected to adopt during the meeting of 4 November a

document inviting the Commission to set the framework for an EU authority against money laundering. It is already in the Commission's agenda to present some proposals to reinforce the anti-money laundering framework at the beginning of 2021.

#### **■** Hazardous Chemicals

The European Commission is considering to amend European rules in order to ensure that hazardous chemicals banned in the Union are not produced for export.

#### **■** Consumer Protection

The Internal Market Committee of the European Parliament proposed a series of measures to strengthen consumer protection and enhance product safety and sustainability by calling on the Commission

to make repairs more appealing, systematic and costefficient. The plenary is expected to vote on the resolution in November.
