### Foreign Subsidies

The EC published the results of the public consultation on its white paper on levelling the playing field as regards foreign subsidies. Positive input came from EU Member States and stakeholders, while more sceptical have been foreign companies. A legislative proposal is expected for the second quarter of 2021.

The EC adopted an explanatory note on the preparation, audit and publication of the financial statements foreseen on the European Single Electronic Format (ESEF).

### **■ Collective Redress**

The Council adopted at first reading its draft directive on representative actions for the protection of the collective interests of consumers within the EU. The Parliament should approve the text before the end of the year. The directive will enter into force on the 20<sup>th</sup> day following that of its publication in the EU Official Journal. Member States will then have 24 months from the entry into force to transpose it into national law.

The EC introduced surveillance of imports from all countries of origin into the EU of renewable fuel ethanol (bioethanol) for a period of one year with the aim to provide quick monitoring of development of imports for specific products.
