■■ State Aid for Energy and Environment

The EC launched a consultation on the revision of certain aspects of the Guidelines on State Aid for Environmental Protection and Energy. The guidelines have been prolonged until 31 December 2021, but they need to be revised in light of new technologies and to be aligned to the new European Green Deal policy framework. On that regard, the scope of the guidelines should be expanded in order to cover more policy objectives. Interested parties can submit their feedback until 07 January 2021. The new guidelines shall be in place by the end of next year.

■ Zero Pollution Ambition

The EC launched a public consultation on its Action Plan for zero pollution for air, water and soil; a key pillar of the European Green Deal. Contributions can be submitted until 10 February 2021.

Dual-Use Items

The Presidency of the Council and the European Parliament negotiators reached a provisional political agreement on a revised regulation setting out the EU regime for the control of exports, brokering, technical assistance, transit and transfer of dual-use items. The agreement now needs to be endorsed by Member States' ambassadors. Then, both Parliament and Council will have to formally adopt the proposed regulation. The Commission presented its original

proposal to review the export control regime in 2016 in order to follow technological developments and include new criteria to the export licenses for certain items due to growing security risks. The agreed text will be available soon.

■ EU-US Trade

The EU agreed on a series of countermeasures against US exports. In particular, the bloc adopted additional tariffs of 15% on US aircraft and 25% on US agricultural goods. Last October the World Trade Organization formally authorised the EU to take such countermeasures against illegal US subsidies to Boeing.

■ Data Transfers

The EC published two sets of draft model data protection clauses, one on standard contractual clauses between controllers and processors located in the EU and the other on the transfer of personal data to third countries, to launch the process to revise the existing Standard Contractual Clauses. Feedback can be submitted until 10 December. The final clauses will be adopted by the Commission after having obtained opinion of Member States' positive The updated clauses will be representatives. complemented by the guidance of the European Data Protection Board.

■ EU Intellectual Property

The Council adopted a set of conclusions on key elements of the future European framework on intellectual property. In particular, the Council underlines the importance of an efficient and transparent system of protection and invites the Commission to present proposals also for the revision of the legal framework on industrial design protection.

■ Consumer Agenda

The EC launched a new vision for European consumer policy, focusing on green transition, digital transformation, effective enforcement of consumer rights and international cooperation. In the coming months the Commission will present the initiatives announced in the agenda, including legal proposals aiming to provide better information on products' sustainability and on the substantiation of green claims based on the Environmental Footprint methods.
