## / Law

### **■ Offshore Renewable Energy**

The EC released its Strategy on Offshore Renewable Energy, which proposes to increase Europe's offshore wind capacity from its current level of 12 GW to at least 60 GW by 2030 and to 300 GW by 2050. As part of the strategy the Commission also aims to promote cross-border cooperation between Member States on long term planning and deployment to promote the scale-up of offshore energy capacity.

### **CO2** Vehicle Emissions

The EC launched its initiative to update the rules for monitoring and reporting data on the CO2 emissions of cars and light vans. Contributions can be submitted until 14 December.

### ■ Climate Target Plan

The EC launched two public consultations on the review of the Renewable Energy Directive and the Energy Efficiency Directive. Consultations will run until mid-February and are part of the preparatory work to deliver on new 2030 emissions reduction target.

#### Aviation

The EC extended by one year the temporary measures introduced last May and due to expire on 31 December 2020 to ease the financial pressure on aviation operators and ground-handlers. The Commission will continue to monitor the situation.

### **■ US Tariffs**

The Council approved a mini tariff package of mutual concessions with the US. The measures will apply with retroactive effect from 1 August 2020 for five years. Now the European Parliament will have to adopt the position in an upcoming plenary session, then the regulation can be formally adopted by the Council and published in the Official Journal of EU.

### ■ Trade and Sustainable Development

The EC launched a new complaints system for reporting market access barriers and breaches of trade and sustainable development commitments in the European trade agreements and under the Generalised Scheme of Preferences.

### ■ Semester Package

The EC presented its autumn economic policy package and policy recommendations for the euro area. Now

the Council and Eurogroup will have to discuss and endorse the package.

### **■** European Industrial Strategy

The Council adopted a set of conclusions to help European industries to recover from the pandemic crisis. In particular, the economic recover should be based on green and digital transition. The Council stresses the importance of a fully functioning and strengthened Single Market, including in the services sector; and an effective level playing field for European businesses. Member States call on the Commission to define key performance indicators for monitoring the industrial strategy and competitiveness by the end of March 2021 and to present an update of its New Industrial Strategy.

### Auditors' Report on EU Merger Control and Antitrust Proceedings

The European Court of Auditors (ECA) released its first report on the Commission's role as an enforcer in the areas of merger and antitrust. In particular, in this audit ECA examined how effectively the Commission detected and enforced infringements. The report underlines that the European watchdog made good use of its enforcement powers, however some challenges remain, such as limited resources, lengthy proceedings, new enforcement problems in digital

markets and the real deterrent effect of record-breaking fines.
