## / Law

### ■■ Dual Use Items

Negotiators of the European Parliament and the Council reached an agreement on the review of the regulation setting up a regime for the control of exports, transfer, brokering, technical assistance and transit of dual-use items. This agreement, which has also been confirmed by the committee in charge of the dossier at the European Parliament, now needs to be formally endorsed by the Parliament as a whole and the Council, before it can enter into force. The update of the rules follows the technological developments and the security risks related in particular to cyber-surveillance tools.

### ■■ EU-US Agenda

The EC published its proposal for a new comprehensive transatlantic agenda that includes proposals and considerations for data transfers, artificial intelligence and cooperation on standards. The European institution is also proposing to create a specific dialogue on the responsibility of online platforms and Big Tech, with a special focus on market distortions and fair taxation. An EU-US Summit is confirmed for next year.

### ■■ Cybersecurity of Connected Devices

The Council approved conclusions setting out the priorities to boost the competitiveness of the European IoT industry. In particular, the Council underlines the need for horizontal legislation to

address the relevant risks for privacy and cybersecurity of connected devices.

### ■ Broadband Networks

The EC opened a public consultation on the review of the Broadband Cost Reduction Directive in order to collect views on incentivising the rollout of fast broadband networks including fibre and 5G. Contributions can be submitted until 2 March 2021.

### ■■ Democracy Action Plan

The EC released its European Democracy Action Plan which contains measures to promote free and fair elections and to strengthen media freedom and counter disinformation. Among the different initiatives of the plan, the Commission intends to implement legal action on political advertising that will address the sponsors of paid content and production and distribution channels; the Code of Practice on Disinformation will become a co-regulatory framework of obligations and accountability of online platforms, in line with the upcoming Digital Services Act.

### ■ Banking

The Council and the European Parliament reached an agreement on amendments to EU rules on financial benchmarks, which have been proposed by the European Commission last July. The agreement needs to be formally adopted by both co-legislators.

### ■ Geo-blocking Regulation

The EC published its review of the Geo-blocking regulation, which prohibits unjustified geographical restrictions on access to goods and services within the EU since December 2018. The report also analyses the potential impact of an extension of the scope of the regulation for cross-border access to copyrighted content. The Commission will launch a dialogue with stakeholders to explore that possibility.

### **Digital Services and Markets Acts**

The release of the Digital Services Act and the Digital Markets Act by the European Commission has been again postponed to December 15, apparently for some internal debates on key elements of the Digital Markets Act. The DMA will introduce a new market

investigation tool and new rules for large online platforms, referred to as “gatekeepers”. According to some rumours, the powers of the new investigative tool will be limited because of some concerns over its operation and its legal basis. Also the scope of provisions related to the gatekeepers is expected to be restricted to few firms.
