Foreign Subsidies

The EC adopted a White Paper on Foreign Subsidies, which proposes a series of options to deal with the distortive effects caused by foreign subsidies in the European Single Market. The Commission also launched a public consultation to collect input from all interested parties on the solutions outlined in the document. Contributions can be submitted until 23 September and will help the Commission to prepare for next year its legislative proposal to address the regulatory gap.

■ Trade Policy

The EC launched a review of the European trade policy to adjust it to the global trends and support the recovery while protecting from unfair practices. A special focus is dedicated to the reform of the WTO and global challenges such as climate change, sustainable development and digital transition. Contributions can be submitted until 15 September. The results of this exercise will feed into a communication that shall be adopted by the end of the year.

■■ Sustainable Finance

The European Parliament adopted the regulation on the establishment of a framework to facilitate sustainable investment, which will amend Regulation 2019/2088 on sustainability-related disclosures in the financial services sector. This is the final step of the adoption process; now the regulation will be published in the Official Journal and enter into force 20 days after its publication.

Key topics will be strategic autonomy and manufacturing of medicines, access to affordable medicines, innovation and environmental sustainability.
