#### ■ State Aid

The EC decided to prolong the validity of certain EU State aid rules which are due to expire by the end of the year and to introduce certain targeted amendments to the existing rules to help companies during the current economic crisis. The Commission adopted a regulation which will amend the General Block Exemption Regulation and the de minimis Regulation; and a communication amending seven sets of State aid guidelines: guidelines on regional state aid; guidelines on state aid to promote risk finance investments; guidelines on state aid for environmental protection and energy; communication on the execution of important projects of common European interest; communication on the application of articles 107 and 108 of the TFEU to short-term export-credit insurance; guidelines on state aid for rescuing and restructuring non-financial undertakings in difficulty.

#### State Aid Temporary Framework

The EC adopted a third amendment to expand the State Aid Temporary Framework to further support micro, small and start-up companies in the context of the coronavirus outbreak. The Commission has also adapted the conditions for recapitalisation measures under the Temporary Framework for those cases where private investors contribute to the capital increase of companies together with the State.

#### EC Communication 2020/C 218/03

#### Antitrust – Interchange Fees Regulation

The EC published a report on the impact of the Regulation 2015/751, the Interchange Fees Regulation for card-based payment transactions. The report concludes that the main objectives of the regulation

have been achieved, therefore a revision of the framework is not necessary for the moment. However, further monitoring and reinforced data gathering in some areas are recommended. The Commission is planning a public hearing with stakeholders on 7 December 2020.

#### EC report on the application of Regulation 2015/751

#### ■ Audiovisual Media Services Directive

The EC adopted non-binding guidelines (on video-sharing platforms and on European works) to help Member States implementing the revised Audiovisual Media Services Directive. The deadline for the transposition of the directive into national law is 19 September.

#### ■ 5G Network Infrastructure

The EC adopted the Implementing Regulation on small-area wireless access points, which are crucial for the deployment of 5G networks. The regulation specifies the physical and technical characteristics of small cells for 5G networks.

# ■ Directive on Security of Network and Information Systems

The EC launched a consultation on the revision of the Directive on Security of Network and Information Systems. With this exercise the European executive will evaluate the functioning of the NIS Directive based on the level of security of network and information systems in the Member States; the evaluation also aims at identifying the direct and indirect regulatory costs and benefits of its implementation. Contributions can be submitted until 13 August. The Commission plans to present a new proposal by the end of the year.

#### **■ Fluorinated Greenhouse Gases**

The EC launched a consultation on the review of Regulation 517/2014, the so-called F-gas Regulation. Contributions can be submitted until 7 September. Together with this exercise, the Commission will organize targeted stakeholder interviews and a stakeholder workshop. The outcome of these activities will be presented in a synopsis report.

#### ■ Solvency II Directive

The EC launched a consultation on the review of the prudential rules for insurance and reinsurance companies. Contributions can be submitted until 21 October. On the basis of the feedback received, the Commission will present a legislative proposal in the Summer of next year.

The EC launched a public consultation to collect inputs on four initiatives of the European consumer policy. Contributions can be submitted until 6 October. The Commission intends to adopt a new consumer agenda by the end of the year.

The Energy Committee of the European Parliament in a recently adopted report outlined its strategy for energy storage, which is considered to be essential for the transition to a decarbonised economy based on renewable energy sources. In particular, the Committee calls on the European Commission to remove regulatory barriers that prevent the development of energy storage projects. The report will be voted by the plenary in mid-July.
