## Foreign Subsidies

The EC launched a consultation on its inception impact assessment on the proposal for a regulation to address distortions caused by foreign subsidies. Contributions can be submitted until 29 October. This assessment follows the White Paper on Foreign Subsidies and the consultation on that, which ended last 23 September, and it opens a second phase of targeted consultations for the Commission with the view to collect further evidence and to prepare its legislative proposal which is expected for second quarter next year.

## ■ State Aid Temporary Framework

The EC sent to Member States for consultation a draft proposal to prolong the framework beyond December, until 30 June 2021, and to extend its scope by enabling Member States to contribute to the fixed costs of companies that are not covered by their revenues and to adapt the conditions for recapitalisation measures.

## ■ Trade

The EC imposed definitive anti-dumping duties on imports of hot rolled stainless steel coils and sheets (SSHR) from Indonesia, China and Taiwan.

#### **■** Taxation

The Council added Anguilla and Barbados to the EU list of non-cooperative jurisdictions for tax purposes. Cayman Islands and Oman were removed from the list, after they improved their tax policy framework.

### ■ Covid and Rail Transport

The Council adopted temporary derogation from existing rules on levying charges for the use of railway infrastructure. The emergency measures will apply retroactively from 1 March 2020 until 31 December

2020, and can be extended if necessary. The regulation is expected to be published in the EU Official Journal on 12 October and it will enter into force the day after.

### **■** Brexit

EU Commission President and UK Prime Minister agreed to intensify the work of the negotiating teams over the coming weeks in order to obtain a trade agreement by the end of the month. However still significant gaps remained in the areas of fisheries, the level playing field and governance.

### **■ Climate Goals**

A final agreement on the 2030 climate target shall be reached by the end of the year. Even if some Member States expressed their concerns for the competitiveness of their industries, a majority of them seems to agree on the need to update the emissionscutting target.

## ■ Digital Identity Framework

EU Prime Ministers and Heads of State agreed on the need to develop an EU-wide framework for secure public electronic identification and called on the European Commission to present a proposal by mid-2021. The future framework should be available to all European businesses and citizens on a voluntary basis and being recognised by private and public service providers for all transactions that require authentication.
