■ Brexit

The Presidents of the Council and the European Commission signed the Agreement on the Withdrawal of the UK. The European Parliament in plenary will have a vote on the agreement next week. Once the plenary has approved it, the Council will adopt the agreement on behalf of the Union on January 30th. As of February 1st the UK will no longer be a member of the EU and of the European Atomic Energy Community. The EU and the UK will then start negotiations on future relations during the transitional period, which shall end on December 31st.

■ Future of Europe

The EC released a communication with its ideas for the upcoming Conference on the Future of Europe, which

is expected to be launched next May and should run for two years. The other European institutions are also working on their contributions for the Conference, and they will prepare a joint declaration which will define the scope, objectives and timing of the conference.

The Council adopted conclusions on climate diplomacy, one of the priorities of the new Commission. Both the Commission and the Member States will work together for a strategic approach to climate diplomacy by next June.

■■ Digital Taxation

EU Finance Ministers had an exchange of views on digital taxation. The debate confirmed that the international approach to the issue is still the best way forward; however, some Member States including France and Italy, stated their intentions to implement national measures if the OECD does not agree on that by the end of the year.

■ Artificial Intelligence

The new European Commission is working on measures to impose a temporary ban on the use of facial recognition technologies by public and private actors. A working document by the Commission is expected by the end of February.
