■ Financial Benchmarks

The Council adopted amendments to the Benchmark Regulation addressing the termination of financial benchmarks. The new rules will give the Commission the power to replace so-called “critical benchmarks”, which could affect the stability of financial markets in Europe and they also aim to avoid systemic risks that might result from the phasing out of the London Inter-Bank Offered Rate (LIBOR) by the end of 2021.
