

## **■** Data Protection

The Civil Liberties Committee of the European Parliament adopted a draft resolution evaluating the General Data Protection Regulation. Lawmakers concluded that so far the GDPR has been successful and that it is not necessary to review it at this stage. However, they called for effective enforcement and adequate resources for supervisory authorities. The European Parliament as a whole will vote on the nonlegislative resolution during the plenary session of 24-25 March.

## ■ Sustainable Products Initiative

The EC launched a consultation to revise the Ecodesign Directive and propose additional legislative measures if needed. The initiative will also focus on

the presence of harmful chemicals in products such as electronics & ICT equipment, textiles, furniture, steel, cement & chemicals. Contributions can be submitted until 09 June.

## ■ Digital Europe Programme

The Council endorsed the new Digital Europe Programme, which aims to boost the digital transformation by providing funding in projects relating to artificial intelligence, supercomputing, cybersecurity, advanced digital skills. Once the European Parliament will adopt the act, the regulation will enter into force on the day of its publication.

#### Chemicals

The Council approved a new Chemicals Strategy setting a long-term vision for the European framework on chemicals. The strategy aims to balance the need of a toxic-free environment with the urgency to strengthen the competitiveness of the European chemicals industry. The new strategy is based on the so-called "safe and sustainable-by-design" approach.

## ■■ Mergers in the Pharma Sector

The Directorate General for Competition of the European Commission together with the Federal Trade Commission, the Canadian Competition Bureau, the UK's Competition and Markets Authority, the US Department of Justice and three Offices of Attorneys General launched a Multilateral Working Group to analyse the effects of mergers in the pharmaceutical sector. The main goal of the group is to identify concrete actions to update the analysis of pharmaceutical mergers.

## ■■ Digital Markets Act

The Body of European Regulators for Electronic Communications published its opinion on the proposal for a Digital Markets Act and a report with some proposals for an effective regulatory intervention on digital gatekeepers. In particular, the body suggests to avoid overlaps with existing frameworks; set up a dispute resolution mechanism; have remedies tailored on a case-by-case basis; and establish an advisory board of national independent authorities to support the EU competent authority in the effective enforcement of the regulation.

#### **■** Data Governance

The European Data Protection Supervisor and the European Data Protection Board adopted a joint opinion on the proposal for a Data Governance Act.

### ■ Taxonomy-related Sustainability Disclosures

The three European Supervisory Authorities (EMA, EIOPA and ESMA) issued a consultation paper on the draft Regulatory Technical Standards regarding disclosures of financial products investing in economic activities contributing to an environmental investment objective. Contributions can be submitted until 12 May.

## ■ Basel III

The European Banking Authority published a decision which will change the Basel III monitoring exercise from its current voluntary nature to a mandatory exercise from December 2021.

## **EBA Decision**

### Banking

The European Banking Authority published two reports on the consistency of risk weighted assets

across all EU institutions authorised to use internal approaches for the calculation of capital requirements for 2020. The reports cover credit risk for high and low default portfolios, as well as market risk.

### ■■ Green Jet Fuel

The proposal that the European Commission is expected to release by April aiming at cutting emissions in the aviation sector will foresee a starting point of 2% in 2025 of green fuel that will raise to 5% in 2030, 20% in 2035, 32% in 2040 and 63% in 2050.
