■ State Aid

The EC submitted to Member States for consultation a draft proposal to extend until 30 June 2022 the State Aid Temporary Framework. The proposal also aims to adjust the scope of the framework by enabling forward-looking investment and solvency support measures for a limited duration.

■■ Energy Intensive Industries

The EC launched a consultation on the transition pathway of the energy intensive industries. In the next eight weeks, the Commission will collect views on a set of scenarios on how energy intensive industries can accomplish the twin transitions. A jointly agreed pathway is expected to be finalised by early 2022 at the latest.

■■ Data Governance Act

The Council agreed on its position on the Data Governance Act, which aims to set up mechanisms to facilitate the reuse of certain categories of public-sector data that are subject to the rights of others through data intermediation services. The proposal also foresees the creation of a new structure, the European Data Innovation Board, to assist the Commission in enhancing the interoperability of data intermediation services. Negotiations with the European Parliament for the adoption of a final text will now start.

■■ Trade and Technology Council

At the first meeting of the Trade and Technology Council, representatives of the EU and US agreed to cooperate on certain common priorities such as foreign investment screening, export controls, artificial intelligence, secure supply chains in semiconductors. They also defined an agenda of topics for future meetings, focusing in particular on data governance and tech platforms, ICT security and competitiveness. Any input from stakeholders will be welcome. Next meeting is planned for next year.

■ Data Transfers – South Korea

The European Data Protection Board issued a non-binding opinion on the European Commission's draft adequacy decision for the Republic of Korea.

■ Corporate Tax System

The Council adopted its position on the proposed directive on the disclosure of income tax information by certain undertakings and branches, known as the public country-by-country reporting (CBCR) directive. For the first time, non-European multinationals doing business in the EU through subsidiaries and branches will also have to comply with these reporting obligations. Now the text needs to be formally adopted by the European Parliament. The directive will enter into force on the 20th day following its publication in the EU Official Journal, then Member States will have 18 months to transpose it into national law.

■ Payment Services

Commission Delegated Regulation of 18 June 2021 supplementing Directive 2015/2366 of the European Parliament and of the Council with regard to regulatory technical standards specifying the framework for cooperation and the exchange of information between competent authorities of the home and the host Member States in the context of supervision of payment institutions and electronic money institutions exercising cross-border provision of payment services has been published in the EU Official Journal.

■ Cross-border Energy Infrastructure Projects

The Energy Committee of the European Parliament reached a common position on the revision of the cross-border energy infrastructure regulation, the so-called TEN-E regulation. According to the amended text, natural gas infrastructure will no longer be eligible for EU funding, except for gas infrastructure already approved under the 4th and 5th list of project of common interest. Negotiations with the Council will start as soon as the Parliament in plenary adopts the text.

■ ■ Energy and Climate

The European Commission intends to present on 14 December its package of measures on Energy and Climate, including the proposals for the revision of the third energy package for gas, for the reduction of methane emissions in the energy sector, a communication on restoring sustainable carbon cycles and a recommendation to address the social and labour aspects of the climate transition.
