■ Competition Policy

The EC adopted its Communication on *A Competition Policy fit for new challenges*, calling for strong and effective competition enforcement. The European executive is currently reviewing a series of tools with the goal to ensure that all policy instruments are fit for purpose and are able to support the green and digital transition. The details and timeframes are outlined in the annex to the communication.

■ State Aid – Broadband Guidelines

The EC launched a targeted public consultation on its proposed revision of the Guidelines on State aid rules for broadband networks. Contributions can be submitted until 11 February. The new guidelines shall be adopted by mid-2022.

■■ European Green Deal

The EC adopted a proposal for a regulation to curb EU-driven deforestation, setting mandatory due diligence rules for companies that intends to place these products on the European market. It also released a proposal for a new regulation to tackle the export of illegal waste and to facilitate intra-EU waste shipments.

Last but not least, the European executive presented its so-called Soil Strategy for 2030.

■ Digital Markets Act

EU Ministers are expected to adopt the general approach on the DMA at the Competitiveness Council on November 25. The Internal Market Committee of the European Parliament, in charge of the file, plans to vote on the proposal on November 22. Then the plenary will have to adopt it, most likely on December

13. Following that, negotiators of the Council, European Parliament and Commission will be ready to start inter-institutional negotiations to finalise the text of the DMA.
