■ Internet of Things

The EC published the final report of its competition sector inquiry into the consumer Internet of Things, which mainly covers: the characteristics of consumer IoT products and services, the features of competition in these markets and the main areas of potential concern raised by stakeholders (such as exclusivity and tying practices, smart device operating systems, extensive access to data, interoperability in the consumer IoT sector). The information collected will provide guidance to the future enforcement and regulatory activity of the Commission. The findings will also contribute to the ongoing legislative debate on the Digital Markets Act proposal.

■ Market Definition Notice

The EC published a call for evidence on the revision of the market definition notice. Contributions can be submitted until 16 February. The new notice aims to ensure that it is updated to reflect latest market developments and it is scheduled for the first quarter of 2023. The Commission intends to release a first draft of the revised Notice in the coming months, then it will launch a public consultation most likely in June. In addition to the consultation on the draft text, workshops with technical experts or representatives from the main stakeholders groups shall take place throughout the year.

EU Finance Ministers held a policy debate on the proposed Council directive on ensuring a global minimum level of taxation for multinational groups. The majority of them stressed the need to transpose into the EU law the agreed rules of international corporate taxation of the OECD/G20 Inclusive Framework as soon as possible.
