# ■ Vertical Block Exemption Regulation

The EC adopted the new Vertical Block Exemption Regulation and the new Vertical Guidelines. The new rules will narrow the scope of the safe harbour as regards dual distribution and parity obligations and enlarge the scope of the safe harbour as regards certain restrictions and practices. Special attention has been dedicated to the assessment of online restrictions, vertical agreements in the platform economy and agreements that pursue sustainability objectives. The revised rules will enter into force on 1 June 2022.

# **■ Merger Control**

The EC launched a consultation on the proposed draft revised Merger Implementing Regulation and the Notice on Simplified Procedure. The aim of this process is to simplify the Commission's merger process for those cases that are unlikely to raise concerns. The new rules are planned to enter into force in 2023. Based on the comments received the Commission will finalise the drafts. The new rules are expected to enter into force in 2023.

#### State Aid

The EC decided not to extend the State Aid Temporary Framework first adopted in March 2020 in the context of the coronavirus pandemic. The current transition plan will allow Member States to provide specific investment and solvency support measures until 31 December 2022 and 31 December 2023 respectively.

## Cybersecurity

Negotiators of the European Parliament and the Council reached a political agreement on the Directive on measures for a high common level of cybersecurity across the Union. The so-called NIS2 Directive will cover medium and large entities from more critical sectors, including providers of public electronic communications services, digital services and waste management. It will also strengthen cybersecurity requirements for companies. The agreement is now subject to formal approval by the two co-legislators. Member States will have 21 months from the entry into force of the directive to transpose it into national law. The agreed text will be available soon.

# ■ Gas Storage Proposal

The Council reached a mandate for negotiations with the European Parliament on a proposal on gas storage in order to improve EU security of supply in the current geopolitical context. The Presidency of the Council will now start negotiations with representatives of the European Parliament in order to agree on a final text.

# ■■ CO2 Emission Standards for Cars and Vans

The Environment Committee of the European Parliament adopted its position on the proposed rules to revise the CO2 emission performance standards for new cars and vans. Now the Parliament in plenary in its session of 6/9 June needs to adopt the text. EU Member States are expected to adopt their position by the end of June, then inter-institutional negotiations on a final text of the proposal will start. The adopted report will be available soon.

# **■ Environmental Liability Directive**

The EC launched a consultation on the evaluation of the Environmental Liability Directive in order to assess whether it is still fit for purpose. Contributions can be submitted until 04 August.

The EC launched a call for evidence as part of the revision of the circular economy monitoring framework. Contributions can be submitted until 3 June.

# ■ Digital Finance

Negotiators of the Council and the European Parliament reached a provisional agreement on the Digital Operational Resilience Act (DORA), which will create a framework with uniform requirements for the security of network and information systems of companies and organisations operating in the financial sector and of third parties which provide ICT-related services to them. The agreement now needs to be formally adopted by the two co-legislators. The agreed text will be available soon.

# ■ Payment Services Directive

The EC launched two consultations on the revised Payment Services Directive II in order to collect views on whether amendments are needed and also on the open finance framework and data sharing in the financial sector. Contributions to both can be submitted until 5 July.
