### ■ ■ Alternative Fuels Infrastructure

The Council adopted a general approach on the proposal for a regulation on the deployment of alternative fuels infrastructure (AFIR), which is part of the Fit for 55 package which aims at reducing net greenhouse gas emissions and achieving carbon neutrality by 2050. The Council's position would give Member States more flexibility on the total power of recharging pools and the rollout of charge points for heavy-duty electric vehicles in sparsely populated areas. Inter-institutional negotiations with the European Parliament on a final version of the regulation will start once the latter agrees on its position.

### ■ ■ Intelligent Transport Systems

The Council adopted a general approach on the proposal for a directive on the deployment of intelligent transport systems (ITS), which will amend the current directive. The revision aims to take account of technological developments since 2010, such as connected and automated mobility, on-demand mobility applications, and multimodal transport and will contribute to the creation of a European mobility data space. Once the European Parliament has adopted its position, inter-institutional negotiations will start. The text of the general approach will be available soon.

## ■ Trans-European Energy Infrastructure

Regulation of the European Parliament and of the Council of 30 May 2022 on guidelines for trans-European energy infrastructure, amending Regulations (EC) No 715/2009, (EU) 2019/942 and (EU) 2019/943 and Directives 2009/73/EC and (EU) 2019/944, and repealing Regulation (EU) No 347/2013 has been published in the EU Official Journal.

A sixth package of restrictive measures against Russia has been adopted. The package contains in particular import ban on Russian seaborne crude oil and petroleum products; financial and business services measures; export restrictions.
