■ EU Emissions Trading System

After the European Parliament rejected the Committee's position, lawmakers finally adopted the report on the revision of the EU Emissions Trading System. Members of the Parliament are proposing to increase the 2030 greenhouse gas emissions reduction target from 61% to 63%; to phase out free allowances in the sectors covered by CBAM from 2027 and to end them by 2032; to introduce a bonus-malus system from 2025 and to use the revenues exclusively for climate action in the Union and Member States. With regard to the new ETS for buildings and transport, the system shall exclude citizens until 2029. Inter-institutional negotiations for a final version of the text between the three institutions, the Council, the European Parliament and the Council can now start.

■ Carbon Border Adjustment Mechanism

The European Parliament adopted its position on the regulation establishing the Carbon Border Adjustment Mechanism. According to the lawmakers' position, the regulation shall have a broader scope, including organic chemicals, plastics, hydrogen, ammonia and indirect emissions to the products proposed by the European Commission; the phasing in CBAM shall start in 2027 and free EU ETS allowances shall end by 2032. Interinstitutional negotiations with the Council and the European Commission in order to agree on a final version of the regulation can now start.

■ Waste

The Council and the European Parliament reached a provisional agreement on the revision of the Persistent Organic Pollutant Regulation with the aim to further

limit the presence of these substances in waste by adding new chemicals on the list and strengthening the concentration limit values.

Pesticide

The EC published its proposal to introduce legally binding targets at EU and national level to reduce by 50% the use of chemical pesticides by 2030 and a ban on all pesticides in sensitive areas. The proposal will have to be discussed by the European Parliament and the Council under the ordinary legislative procedure.

■ Corporate Sustainability Reporting

The Council and the European Parliament reached a provisional agreement on the Corporate Sustainability Reporting Directive (CSRD), which will amend the Nonfinancial Reporting Directive of 2014, introducing more detailed reporting requirements for large companies on sustainability issues such as environmental rights, social rights, human rights and governance factors. Large public-interest companies with more than 500 employees and all large companies and all companies listed on regulated markets will be covered by the directive. The provisional agreement is subject to approval by the Council and the European Parliament. The directive will enter into force 20 days after its publication in the EU Official Journal. The text of the agreement will be available soon.

■ Trade Agreements

The EC presented its plan to further strengthen the implementation and enforcement of Trade and Sustainable Development chapters of the EU trade agreements in order to better protect the environment and labour rights.

■■ Aviation Guidelines

The EC launched a consultation on the extension of the transitional period during which operating aid to regional airports can be declared compatible with the Guidelines on State aid to airport and airlines of 2014. Contributions can be submitted until 21 July.

The Council agreed its position on the revision of the Solvency II directive, paving the way for interinstitutional negotiations with the European Parliament on a final version of the text to start.

■ Artificial Intelligence

The delegation of the Czech Republic, that will hold the rotating Presidency of the Council as of July, shared a discussion paper with the other Member States on the way forward with regard to the AI Act. In particular, the delegation aims at collecting inputs and views on some concepts such as definition, high-risk systems, governance and national security. The document will serve as basis for debate in the Telecom Working Party scheduled for 5 July. The upcoming Presidency intends to reach a compromise agreement among Member States before the Summer break.
