

#### Gas Supply

The EC presented its proposal for a new legislative tool that will set a target for all Member States to reduce gas demand by 15% between 1 August 2022 and 31 March 2023, with the possibility for the Commission to declare a "Union alert" on security of supply, imposing a mandatory gas demand reduction in case of emergency. The Commission also intends to intensify its commitment on supply diversification, including through joint purchasing of gas.

#### ■ State Aid Temporary Crisis Framework

The EC adopted an amendment to the State aid Temporary Crisis Framework adopted last March in order to support the economy in the context of the invasion of Ukraine by Russia. The amendment extends the framework by providing for the a series of additional types of aid, such as measures accelerating the rollout of renewable energy and to facilitate the decarbonisation of industrial processes. Aid under these sections may be granted until 30 June 2023. The adopted amendment complements the Commission's package on gas supply.

### ■■ Digital Markets Act

The Council adopted the Digital Markets Act, which will define new rules for large online platforms, the so-called gatekeepers. In the coming months the text will be published in the EU Official Journal and will start to apply six months later.

#### **■** Sanctions Russia

The Council adopted a so-called "maintenance and alignment" package to tighten the existing sanctions against Russia and introduce a new prohibition to purchase, import or transfer directly or indirectly gold. (covering also jewellery). The package also extends the list of dual use items and clarifies certain aspects of the existing measures, for instance in the field of public procurement and aviation. Last but not least, the list of individuals and entities under sanctions have been extended.

The Council adopted its position on the proposal for a regulation on general product safety. The revised rules will transform the 2001 general product safety directive into a regulation and will ensure that products of the digital age meet the safety standards. Interinstitutional negotiations with the European Parliament will start soon.
