■ Energy Crisis

The European Commission is working on a set of emergency interventions to tackle electricity demand and high electricity prices. EU Energy Ministers will meet on 9 September to discuss the Commission's proposals, including a possible price cap for electricity. A full reform of the European electricity market is envisaged for the beginning of next year.

■ Connected Devices

The European Commission shall present its proposal for the cybersecurity of connected devices in mid-September. The act shall include a framework for cybersecurity standards, best practices and guidelines.
