■ Competition – HBERs

The EC launched a consultation on the draft text of two regulations extending the validity until 30 June 2023 of the horizontal block exemption regulations on Research & Development and Specialisation Agreements (HBERs), which are due to expire at the end of the year. Contributions can be submitted until 14 November.

■ Trade – Anti-coercion Instrument

The International Trade Committee of the European Parliament adopted its negotiating position on the proposal for a regulation on the protection of the EU from economic coercion by third countries. Lawmakers amended the original Commission's proposal by broadening the scope of the instrument in order to

include the mere threat of coercion as a reason to react to that through the imposition of tariffs but also other reactive measures. The Committee introduced a provision for a review of the instrument in three years to check its compatibility with the European Blocking Statute, currently under review. The Parliament in plenary needs to adopt the text. Inter-institutional negotiations with representatives of the Council will start once Member States have adopted their position.

■ Markets in Crypto-Assets

The Economic and Monetary Affairs Committee of the European Parliament adopted the provisional agreement reached with the Council on the proposal for a Regulation on markets in crypto-assets. The text needs to be confirmed by the Parliament in plenary and also adopted by the Council.

■ Standardisation Rules

The Council and the European Parliament reached a provisional political agreement on the proposal to amend the European standardisation regulation which will introduce new requirements for European standardisation organisations to ensure the involvement of national standardisation bodies. The provisional agreement is subject to approval by the two co-legislators. The regulation will enter into force on the 20th day after its publication in the EU Official Journal. The agreed text will be available soon.

The EC published its weekly report for all dangerous consumer products, with the exception of food, pharmaceutical and medical devices.

Energy Crisis

On 18 October the European Commission is expected to release its proposals on joint gas purchasing and on an alternative price benchmarks for gas.

■ Environmental Crime

EU Ministers held a discussion on the draft environmental crime directive, which was presented by the European Commission last December. The new law will replace the existing directive of 2008, updating the list of offences covered and including new types of environmental damage, such as illegal water abstraction, illegal trade in wood or the illegal recycling of polluting boats. A partial general approach was

reached in June, now Member States will have to agree on the remaining part. The Presidency of the Council aims to reach an overall general approach in December.

■ Artificial Intelligence

The Czech Presidency of the Council shall present by the end of the month a new compromise proposal on the Al Act.
