State Aid – Temporary Crisis Framework

After Member States' consultation of last week, the EC adopted an amendment to the State aid Temporary Crisis Framework which will prolong all measures until 31 December 2023; increase the ceilings for limited amounts of aid; introduce additional flexibility for liquidity support to energy utilities for their trading activities; increase flexibility and support possibilities for companies affected by rising energy costs; introduce new measure aimed at supporting electricity demand reduction; clarify the criteria for the assessment of recapitalisation support measures.

Digital Markets Act

The Digital Markets Act (DMA) entered into force and as of 2 May 2023 it will start to apply. Afterwards, within two months and at the latest by 3 July 2023, potential gatekeepers will have to notify their core platform services to the EC if they meet the thresholds. At the latest by 6 September 2023, gatekeepers will be designed. Following that, they will have six months to comply with the requirements in the DMA (at the latest by 6 March 2024). In the next months, the EC will organise a number of technical workshops with interested stakeholders; the first will take place on 5 December and will focus on the "self-preferencing" provision. The Commission is also working on an implementing regulation that contains the provisions on the procedural aspects of notification.

assessment, and the Commission's empowerment to adopt technical specifications.
