The EC is collecting feedback on the Late Payments Directive. Contributions can be submitted until 09 February. A public consultation for the revision of the rules will be launched by the Spring. The Commission plans to adopt a revised directive by the end of the year.

Antitrust – Sustainability Agreements in Agriculture

The EC launched a public consultation on draft guidelines covering the exemption from competition rules of sustainability agreements in the agricultural sector. Contributions can be submitted until 24 April. The EC will then analyse the comments received and if necessary review the draft. The final guidelines shall be in place by 8 December 2023.

■ Digital Decade Programme

The 2030 Digital Decade Policy Programme has entered into force. It consists of a monitoring and cooperation mechanism to achieve common targets for Europe's digital transformation by 2030, focusing in four key areas: digital skills, infrastructure including connectivity, digitalisation of businesses and online public services. The EC will publish an annual progress report, the so-called State of the Digital Decade, to provide an update and assessment of the actions taken by Member States and to lay down recommendation on progress towards the targets.

■ Commission Agenda

The European Commission is planning to present its proposal for the European Critical Raw Materials Act

on 14 March; while the Patent Package, which will cover also compulsory licensing, standard essential patents and supplementary protection certificates, is expected for 26 April.

■ Renewable Energy Directive

The fourth inter-institutional negotiating meeting between representatives of the European Parliament, the Council and the Commission is scheduled for 7 February and it shall focus on targets for the use of renewable energy in the transport sector.

■ Digital Markets Act

The European Commission shall present a regulation on the implementation of the Digital Markets Act in the coming months, before the entry into force in May of the DMA.
