■■ Cars and Vans Emissions

The European Parliament adopted the text of the agreement reached during the inter-institutional negotiations on the proposal on CO2 emission standards for cars and vans, part of the Fit for 55 package. The text provides for a 100% reduction in emissions by 2035. Every two years, starting from the end of 2025, the Commission will publish a report to evaluate the progress towards zero-emission road mobility. The text will now have to be formally endorsed by Council, before being published in the EU Official Journal.

■■ Heavy-duty Vehicles Emissions

The EC presented its proposal for new CO2 emissions targets for new heavy-duty vehicles from 2030 onwards. Interested parties can submit feedback on the proposal until 13 April. The European Parliament and the Council will have to discuss the proposal and agree on a common text.

■ Renewable Hydrogen

The EC presented its draft delegated acts which define what constitutes renewable hydrogen for the EU, under the Renewable Energy Directive. In particular, one specifies the conditions under which hydrogen can be considered renewable and hydrogen-based fuels can be considered renewable fuels of non-biological origin (RFNBOS), the other provides a methodology for calculating life-cycle greenhouse gas emissions for RFNBOS.

■ Blockchain

The EC launched the European Regulatory Sandbox for Blockchain, i.e. a pan-European framework for regulatory dialogues with the aim to increase legal certainty for innovative blockchain solutions, which will run until 2026. The sandbox is open to companies from all industry sectors.
