The EC published the set of responses to the questions submitted by the European Supervisory Authorities with regard to the Sustainable Finance Disclosures Regulation (SFDR), with the aim to facilitate the application of the SFDR by financial market participants, especially in the context of the interaction between the SFDR and the different pieces of the sustainable finance framework.
