# Law

## State Aid

The EC launched a public consultation on its draft proposal to prolong until 04 April 2027 the 2014 Guidelines on State aid to airports and airlines, without any other changes. Contributions can be submitted until 05 June 2023.

## Anti-corruption

The EC presented its proposal to fight corruption in the EU and worldwide. Under the proposed rules, Member States would need to adapt their criminal codes to harmonise definitions and penalties across the EU. In addition to that, the proposed directive aims to ensure effective investigation and prosecution of corruption and better cross-border cooperation between competent authorities. The High Representative of the Union for Foreign Affairs and Security Policy, with the Commission's support, proposes to complement the Common Foreign and Security Policy (CFSP) toolbox of restrictive measures with a dedicated sanctions regime to fight serious acts of corruption worldwide, in case such acts affect the EU's values, interests, security, independence and integrity.

## **Green Transition**

The Council adopted its position on the proposed directive to empower consumers for the green transition, which will amend the Unfair Commercial Practices Directive and the Consumer Rights Directive. As soon as the European Parliament adopts its position, negotiations with the Council on the final shape of the directive can start.

# **Digital Services Act**

The EC launched a consultation on its delegated regulation on how independent audits should be conducted under the Digital Services Act for Very Large Platforms (VLOPs) and Very Large Online Search Engines (VLOSEs). Contributions can be submitted until 02 June. The regulation will be adopted by the end of the year.

## **Intellectual Property**

Negotiators of the Council and the European Parliament reached a provisional agreement on the regulation for geographical indication protection for craft and industrial products, which will cover products such as glass, textiles, porcelain, cutlery, pottery, musical instruments and furniture. The agreement now needs to be endorsed and formally adopted by both institutions. The agreed text will be available soon.

## Chemicals

The EC adopted new rules to prohibit the use and placing on the market of lead in polyvinyl chloride (PVC) articles, including imports.

## Trade – Ukraine

The implementing regulation extending of one year the suspension of customs duties on imports from Ukraine has been adopted and published in the EU Official Journal. The current regulation, which concerns four agricultural products (wheat, maize, rapeseed and sunflower seed) originating in Ukraine will be in force until June 2024.
