# Law

#### **Artificial Intelligence**

The Internal Market Committee and Civil Liberties Committee of the European Parliament adopted the Parliament's report on the Artificial Intelligence Act. This will be the world's first comprehensive legislation on Al and it will follow a risk-based approach establishing different obligations for providers and users based on the level of risk. Among other things, the lawmakers included bans on biometric surveillance and the right to make complaints about Al systems. The Parliament in plenary needs to endorse the report, most likely during the mid-June session. Then negotiations with the Council on the final version of the legislation will start.

#### Greenwashing

The European Parliament in plenary adopted the draft legislation on empowering consumers for the green transition, improving product labelling and durability while putting a stop to misleading claims. Interinstitutional negotiations between representatives of the Council and the European Parliament on the final shape of the proposed directive will start soon.

#### **Zero Pollution**

The EC launched a public consultation to collect input on the implementation of the "polluter pays" principle in the EU. Contributions can be submitted until 04 August. This exercise is part of a comprehensive policy evaluation and the feedback received will serve to prepare a recommendation on how to better implement it.

#### **Methane Emissions**

The European Parliament adopted its report on the proposed regulation on methane emissions reduction in the energy sector. The new rules will target direct methane emissions from the oil, fossil gas and coal industries; Members of the Parliament also call for the inclusion of the petrochemicals sector. Negotiations with the Council on the final shape of the legislation can now start.

#### State Aid

The General Court of the EU annulled the decision of the European Commission approving the recapitalization of Lufthansa by Germany (Cases T-34/21 & T-87/21) under the State aid Temporary Framework in the context of the Covid-19 pandemic.

#### **Hazardous Chemicals**

The EC launched a public consultation in preparation of a mechanism to prohibit the production and/or export of certain hazardous chemicals banned in the EU because of their dangerous properties and unacceptable risks to human health or the environment. Contributions can be submitted until 31 July. The initiative shall be adopted in the fourth quarter of the year.

#### **Medical Devices**

The EC invited interested parties to submit information that could assist the scientific committee with their assessment and update of the existing guidelines on the benefit-risk assessment of the presence of phthalates in certain medical devices. Contributions can be submitted until 17 July.

#### **EU-US Trade and Technology Council**

Representatives of the European Commission and the US administration will meet at the end of the month for the 4<sup>th</sup> summit of the Trade and Technology Council (TTC). On the agenda of the meeting there is the issue of the transition towards a net zero economy. In addition to that, the two parties will also discuss the introduction of new export controls on sensitive items, especially on semiconductors.

### **EU – ASEAN Competition Policy**

Representatives of the EU and the Association of Southeast Asian Nations (ASEAN) met in Bangkok to discuss cooperation on competition policy and enforcement. Discussions covered in particular cartel investigation techniques and subsidy control.


