Law

Data Act

Negotiators of the European Parliament, the Council and the European Commission reached a provisional agreement on a new regulation on harmonized rules on fair access to and use of data, so-called Data Act. The new law will establish rules governing the sharing of data generated by connected products or related services. The deal will have to be endorsed by both the European Parliament and the Council, before being published in the EU Official Journal. The rules will enter into force 20 days following the publication and will become applicable 20 months after the entry into force. The agreed text will be available soon.

Payment Services

The EC presented its proposals to further digitalize the financial sector. The package consists of a series of measures to review the current Payment Services Directive (PSD2) and to establish a framework for Financial Data Access. The proposals will have to be discussed by the Council and the European Parliament.

Financial Market

Negotiators of the European Parliament and the Council reached a provisional agreement on the proposal to review the Markets in Financial Instruments Regulation (MiFIR) and the second Markets in Financial Instruments Directive (MiFID II), to increase transparency and availability of market data. The text needs to be formally adopted by both the Council and the European Parliament before it can be published in the EU Official Journal. The agreed text will be available soon.

Single Currency Package

The EC presented its package consisting of two legislative proposals on the legal tender of euro cash to safeguard the role of cash and on establishing the legal framework for a possible digital euro as a complement to euro banknotes and coins. The proposals will have to be discussed by the Council and the European Parliament.

Brexit – Financial Services

EU Commissioner for Financial Services signed on behalf of the European Commission the Memorandum of Understanding establishing a framework for structured regulatory cooperation in the area of financial services with the UK. The final version will be published soon.

Central Securities Depositories

Negotiators of the Council and the European Parliament reached a provisional agreement on the proposal to review the rules on central securities depositories (CSDs) in order to reduce the financial and regulatory burden on CSDs. The provisional agreement will have to be formally adopted by the Council following legal and linguistic revision of the text. The regulation will then be published in the EU Official Journal.

Banking Package

Negotiators of the European Parliament and the Council reached a provisional agreement on the proposals to amend the Capital Requirements Regulation and the Capital Requirements Directive, which will implement the final set of international standards agreed in the Basel Committee on Banking Supervision (so-called Basel III). The agreement now needs to be formally adopted by both the co-legislators, the European Parliament and the Council before being published in the EU Official Journal. The new rules amending the Capital Requirements Regulation are expected to apply from 1 January 2025; while the amendments to the Capital Requirements Directive will have to be transposed by Member States by 30 June 2026. The agreed text will be available soon.

Anti-coercion Instrument

The International Trade Committee of the European Parliament voted in favor of the inter-institutional agreement reached with the Council and the European Commission on the proposal for a regulation on the protection of the Union and its Member States from economic coercion by third countries. The Parliament in plenary will have to confirm the vote, then the Council can officially adopt it.

EU-New Zealand

The Council adopted a decision on the signature of the free trade agreement (FTA) with New Zealand. After that, the Council will request the European Parliament to give its consent to the conclusion of the Agreement; then the agreement must be ratified.

Intelligent Transport Systems

The Transport Committee of the European Parliament approved the provisional agreement reached with the Council on the deployment of Intelligent Transport Systems. Next step is the adoption by the Parliament in plenary and by the Council.

Sustainable Aviation Fuels

The Transport Committee of the European Parliament approved the provisional agreement reached with the Council on the so-called "ReFuelEU Aviation" regulation on sustainable aviation fuels, which will set out a roadmap for the deployment of sustainable fuels. The text now needs to be approved by the Parliament in plenary, then it can be adopted by the Council.

EU-China

In the conclusions of the European Council meeting of 29 - 30 June, EU Heads of State and Government reaffirmed the "Union's multifaceted policy approach towards China". While Beijing continues to be an important trade and economic partner, the EU will "seek to ensure a level playing field and will continue to reduce crucial dependencies and vulnerabilities, including in its supply chains".

Digital Trade Negotiations

The European Commission will soon start digital trade agreement negotiations with Singapore and the Republic of Korea.

EU-Japan Relations

The EU and Japan held their third High-Level Economic Dialogue, during which they focused on economic security and on the necessity to build resilient supply chains in strategic areas.

Critical Raw Materials

The Governments of Germany, France and Italy agreed to coordinate their actions on the proposal on a Critical Raw Materials Act.
