# Law

### **Digital Markets Act**

The EC designated the first list of companies to be considered as gatekeepers under the DMA. Alphabet, Amazon, Apple, ByteDance, Meta, Microsoft will now have six months to ensure full compliance with the obligations imposed by the DMA. In parallel, the European executive opened four investigations to further assess Apple's iMessage service and Microsoft's Bing, Edge and Advertising businesses.

#### Sanctions

The EC released a guidance note which aims to provide European operators with a general overview on the possible risks of sanctions circumvention.

#### **Trade Defense**

The EC published its report on the EU's anti-dumping, anti-subsidy and safeguard activities and the use of trade defense instruments by third countries targeting the EU in 2022. According to the document, the highest number of measures concern imports from China, Russia, India, Korea and the US.

#### **Critical Raw Materials**

The Industry Committee of the European Parliament adopted its report on the Critical Raw Materials Act. The plenary is expected to vote on the file on 14 September in order to start inter-institutional negotiations on the final version of the law as soon as possible. The report will be available soon.

### **Capital Requirements Regulation**

The EC adopted a set of technical standards which set out the criteria for the identification of shadow banking entities, ensuring the harmonization and comparability of exposures reported by credit institutions, as required by the Capital Requirements Regulation. The text has been submitted to the European Parliament and the Council for a three-month scrutiny period.

### **European Standardization**

The EC is collecting feedback on Regulation 1025/2012 on European standardization, as part of its evaluation of the law. Contributions can be submitted until 29 September. A public consultation will then follow.

#### **Competition Commissioner**

European Commission Vice-President Margrethe Vestager takes a period of temporary withdrawal from the Commission as she applied for a job at the European Investment Bank. Commissioner Didier Reynders will take over Vestager's portfolio on competition, while Commissioner Vera Jourova has been assigned the responsibility of the digital agenda.

#### **Directorate-General for Trade**

The EC appointed Sofia Munoz Albarran as Director for "Resources, Inter-institutional Relations, Communications and Civil Society" at the Commission's Directorate-General for Trade (DG Trade). She will oversee the implementation of the European trade policy with countries outside the EU.

#### **Energy – Greenwashing**

The Council of European Energy Regulators published a set of guidelines on good practice for trustworthy information on green offers and consumer protection against misleading marketing.
