Law

Greenwashing

The negotiators of the European Parliament and the Council reached a provisional political agreement on the proposal for an EU Directive aimed at empowering consumers through adequate information on the durability and reparability of products and to combat the practice of erroneous claims of sustainability (so-called greenwashing). The proposal will amend the Unfair Commercial Practices Directive and the Consumer Rights Directive. The provisional agreement now needs to be endorsed and formally adopted by the European Parliament and the Council. The text of the agreement will be available soon.

EC proposal for a Directive

EU-US Data Privacy Framework

Commission Implementing Decision of 10 July 2023 pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council on the adequate level of protection of personal data under the EU-US Data Privacy Framework has been published in the EU Official Journal.

Generalized Scheme of Preferences

The International Trade Committee of the European Parliament voted in favor of the proposed regulation to extend for a further 4 years the current Generalized Scheme of Preferences (GSP), due to expire at the end of 2023. The plenary is expected to endorse the text at the beginning of October. If not adopted in time, all imports under GSP would revert to standard most favored nation treatment.

Dual-use Items

The EC released a proposed updated version of the list of dual-use items, which will amend Regulation (EU) 2021/1821. The European Parliament and the Council have now two months to propose amendments before it enters into force.

Commission delegated regulation

State Aid

The EC intends to set up a forum, the so-called Joint European Forum for Important Projects of Common European Interest (JEF-IPCEI), with experts from Member States and the Commission services in addition to representatives of businesses and academia with the aim to improve the selection and implementation of the IPCEI. A first meeting is scheduled for October.

Gigabit Infrastructure Act

The Industry Committee of the European Parliament in charge of the file adopted its report on the Gigabit infrastructure Act, which aims to reduce the cost and simplify the administrative procedures for granting permits. The report will have to be confirmed by the European Parliament in plenary and it then become the basis for negotiations with the Council on a final version of the law. The adopted text will be available soon.

RAPEX Weekly Report

The EC published its weekly report for all dangerous consumer products, with the exception of food, pharmaceutical and medical devices.

Product Liability Directive

The responsible Committees of the European Parliament are expected to vote on the report on the proposal for a new directive on liability of defective products, which aims to adapt the current EU framework on product liability to the requirements of the digital age and the circular economy on 9 October.

Packaging and Packaging Waste

The Environment Committee of the European Parliament shall adopt its report on the proposal to review the Packaging and Packaging Waste Regulation on 24 October. The plenary is scheduled to confirm the vote in mid-November.

EU-China Digital Dialogue

At the second High-level Digital Dialogue meeting between the EU and China, the two parties signed an action plan on the safety of products sold online.
