## Law

### **Vehicle Safety**

The EC is collecting feedback on its initiative to update standards for in-vehicle emergency call systems (eCall), in particular with regard the transition to 4G and 5G networks. Contributions can be submitted until 24 November. The Commission plans to adopt the delegated regulation before the end of the year.

### **Export Controls**

The EC published an initial compilation of Member States' national export control lists. EU countries are now able to impose authorization requirements on exports of items included in other countries' control lists, as long as these are included in the list of the European Commission.

The EU and Japan reached an agreement on cross-border data flows. These provisions will be included in the EU-Japan Economic Partnership Agreement once ratified.
