Law

Data Act

The European Parliament voted in favor of the political agreement reached during the negotiations with the Council on the proposal for a regulation laying out harmonized rules on fair access to and use of data, so-called Data Act. The new legislation establishes rules on the sharing of data generated through the use of connected products or related services (e.g. the Internet of Things, industrial machinery). The text now needs to be formally endorsed by the Council.

Adopted text

State Aid Temporary Crisis and Transition Framework

The EC sent to Member States for consultation a draft proposal to amend the phase-out schedule of the provisions of the State aid Temporary Crisis and Transition Framework. Among the measures proposed by the Commission there is the prolongation of three months of the provisions enabling Member States to continue to grant limited amounts of aid and aid to compensate for high energy prices until 31 March 2024. The Commission is expected to adopt the amendments to the framework in the coming weeks.

Euro 7

The European Parliament adopted its report on a new regulation for the type-approval of motor vehicles with respect to their emissions and battery durability, which will replace the Euro 6 regulation for cars and light-duty vehicles and the Euro VI regulation for heavy duty vehicles. Inter-institutional negotiations with the Council on the final shape of the regulation can now start.

Vehicle Safety

The EC is collecting feedback on its initiative to introduce document templates for the type-approval of certain motor vehicle safety systems, such as intelligent speed assistance system, driver drowsiness and attention warning system, event data recorder, amending type-approval rules under Regulation 2021/535. Contributions can be submitted until 5 December.

Waste Electrical and Electronic Equipment

The European Parliament adopted its report on the proposal for a directive on waste electrical and electronic equipment (WEEE), which will amend Directive 2012/19/EU. Inter-institutional negotiations on the final shape of the law will soon start.

Euro Instant Payments

Negotiators of the European Parliament, the Council and the European Commission reached a political agreement on the proposal for a regulation amending Regulations 260/2012 and 2021/1230 as regards



instant credit transfers in euro, as part of the Capital Markets Union. The text now needs to be formally adopted by both the European Parliament and the Council before entering into force. The text of the agreement will be available soon.

Crypto-Assets

The EC is collecting feedback on its delegated regulation which will supplement Regulation 2023/1114 by specifying the procedural rules for the exercise of the power to impose fines or periodic penalty payments by the European Banking Authority on issuers of significant asset-referenced tokens and issuers of significant e-money tokens. Contributions can be submitted until 06 December.

Non-Road Mobile Machinery

The Council adopted its position on the proposed regulation for the approval and market surveillance of non-road mobile machinery circulating on public roads, which intends to create harmonized road safety requirements. Inter-institutional negotiations on the final shape of the regulation will start as soon as the European Parliament adopts its position.

Combined Transport

The EC presented its proposal for a directive on combining transport modes for more sustainable and competitive intermodal. The proposal will update the current framework. The text will have to be discussed and agreed by the European Parliament and the Council.

The EC published its weekly report for all dangerous consumer products, with the exception of food, pharmaceutical and medical devices.

Markets in Crypto-Assets Regulation

The European Banking Authority launched a consultation under the Markets in Crypto-Assets Regulation (MiCAR) on draft Regulatory Technical Standards specifying the methodology to be applied by issuers of asset-referenced tokens (ARTs) and of e-money tokens (EMTs) denominated in a non-EU currency for reporting transactions associated to uses of these tokens "as a means of exchange". In addition to that, the Authority published a consultation on draft Implementing Technical Standards on the related reporting requirements under MiCAR. Contributions can be submitted until 8 February.


