Law

Data Act

The Council formally adopted the regulation on harmonized rules on fair access to and use of data, so-called Data Act. Following legal-linguistic review the new regulation will be published in the EU Official Journal and will enter into force the twentieth day after this publication.

Data Act

Cyber-Resilience Act

Negotiators of the European Parliament, the Council and the European Commission reached a provisional agreement on the so-called Cyber-Resilience Act, the proposed legislation on EU-wide cybersecurity requirements for the design, development, production and making available on the market of hardware and software products. The new law will apply to all products directly or indirectly connected to another device or a network. Work on the text will continue at technical level, then it will have to be endorsed and formally adopted by the European Parliament and the Council. The agreed text will be available soon.

State Aid

The EC prolonged until 31 December 2025 the possibility of granting rescue and restructuring aid to non-financial undertakings in difficulty under the Guidelines on State aid for rescuing and restructuring of non-financial undertakings in difficulty, without any other substantive changes.

Communication from the Commission

Industrial Emissions

Negotiators of the Council and the European Parliament reached provisional political agreements on the revision of the Directive on industrial emissions (IED) and the Regulation on the establishment of an industrial emissions portal (IEP). The new law will also cover activities involved in the extraction of metals and large-scale production of batteries. The new rules also aim to improve environmental data reporting by upgrading the existing European pollutant release and transfer register (E-PRTR). The agreements need to be formally endorsed and adopted by the European Parliament and the Council. The agreed texts will the available soon.

Renewable and Natural Gases

Negotiators of the European Parliament and the Council reached a provisional political agreement on the directive to establish common rules for the internal markets in renewable and natural gases and in hydrogen. The deal now needs to be endorsed and formally adopted by both institutions. The text will be available soon.

Electricity Grids

The EC proposed an action plan to address the missing links of the clean energy transition, with the aim to guarantee that the European electricity grids will operate more efficiently.

European Green Deal

The EC adopted the first list of Projects of Common Interest (PCIs) and Projects of Mutual Interest (PMIs) that will benefit from streamlined permitting and regulatory procedures.

Central Securities Depositories

The Council adopted the regulation on central securities depositories (CSDs), which will amend Regulation 909/2014 and Regulation 236/2012. The new law will reduce the financial and regulators burden on CSDs and improve their ability to operate across borders. The regulation will soon be published in the EU Official Journal and will enter into force twenty days after its publication.

Regulation on settlement discipline, cross-border provision of services, supervisory cooperation, provision of banking-type ancillary services and requirements for third-country central securities depositories

European Single Access Point

The Council adopted the regulation creating the European Single Access Point (ESAP), a platform that will make financial and non-financial information about European companies and investment products easier to consult. The regulation will be published in the EU Official Journal in the coming weeks and it will enter into force twenty days after its publication.

Trade in Firearms

The Council approved a negotiating mandate on the revision of the Regulation on import, export and transit measures for firearms for civilian use. Inter-institutional negotiations with the European Parliament on the final text can now start.

EU-New Zealand Trade

The EU completed its procedures ratifying the free trade agreement with New Zealand, the first agreement to integrate the EU's new approach to trade and sustainable development. Before the deal can enter into force, New Zealand will need to complete its ratification procedure, which shall be done by the first or second quarter of next year.

The European Parliament is expected to endorse the political agreement reached with the Council on the final shape of the regulation on 12 December. Then the text will have to be endorsed by the Council before being published in the EU Official Journal.

Net Zero Industry Act

EU Ministers are expected to reach a general approach on the regulation to strengthen Europe's net-zero technologies manufacturing sector in Europe (so-called Net-Zero Industry Act) on 7 December.


