Eco-design Regulation

Negotiators of the European Parliament, the Council and the European Commission reached a provisional political agreement on the proposed regulation establishing a framework for setting eco-design requirements for sustainable products. The new regulation will replace the 2009 directive, expanding the scope of the current legislation to almost all categories of products. The provisional agreement now needs to be endorsed and formally adopted by the European Parliament and the Council. The agreed text will be available soon.

EU-UK Electric Vehicles Rules of Origin

The EC presented its proposal for one-off extension until 31 December 2026 of the current rules of origin for electric vehicles and batteries under the EU-UK Trade and Cooperation Agreement. The text now needs to be discussed in the Council. In addition to that, the EC announced additional funding of up to 3 billion euro for three years to boost the European battery manufacturers.

Design Protection Package / Industrial Designs

Negotiators of the European Parliament, the Council and the European Commission reached a provisional agreement on the revision of the directive for the legal protection of designs and the regulation on Community designs. The new law will also introduce a "repair clause" with rules regarding exceptions from design protection for spare parts used for repair of complex products, such as cars. The provisional agreement now needs to be formally adopted by the European Parliament and the Council. The agreed text will be available soon.

Digital Services Act

The EC launched a consultation on the Implementing Regulation on transparency reporting under the DSA. Interested parties shall submit their feedback by 24 January. The regulation is expected to be adopted in the beginning of 2024.

Net-Zero Industry Act

The Council adopted its position on the regulation establishing a framework of measures for strengthening Europe's net-zero technology products manufacturing ecosystem, so-called Net-Zero Industry Act. Interinstitutional negotiations with the European Parliament on the final version of the law can now start.

The EC is collecting feedback on the Commission delegated regulation amending Delegated Regulation 2019/331 as regards transitional Union-wide rules for harmonized free allocation of emission allowances.

Green Freight Package

The Council adopted its position on the proposal for a regulation on the accounting of greenhouse gas emissions of transport services, which aims to improve the calculation and information on the greenhouse gas emissions of transport services setting out a common regulatory framework. Once the European Parliament adopts its position, inter-institutional negotiations on the final shape of the law will start.

The EC adopted guidelines on how to design sustainability agreements in the field of agriculture, in the context of the Common Agricultural Policy Reform for 2023-2027.

Chemical Substances

Negotiators of the European Parliament, the Council and the European Commission reached a deal on the regulation for classification, labelling and packaging of chemical substances (CLP regulation). The regulation updates the 2008 legislation, clarifying the rules on labelling chemical substances and the required information for chemicals sold online. The provisional agreement now needs to be formally adopted by the European Parliament and the Council. The agreed text will be available soon.

Chemicals Assessment Reform

The EC presented three legislative proposals on the assessments of chemicals across the European legislation, strengthening cooperation and scientific work on chemicals and ensuring early detection and action on emerging chemical risks. The three proposals will now be examined by the European Parliament and the Council under the ordinary legislative procedure.

The Council adopted its position on the gigabit infrastructure act (GIA), which will replace the 2014 broadband cost-reducing directive. Inter-institutional negotiations with the European Parliament on the final shape of the law will soon start.

Daisy Chains

Negotiators of the Council and the European Parliament reached a provisional political agreement on the Daisy Chains proposal, which is a targeted amendment of the Bank Recovery and Resolution Directive (BRRD) and the Single Resolution Mechanism Regulation (SRMR). The agreement needs to be formally adopted by the European Parliament and the Council. The agreed text will the available soon.

Packaging

The Council is expected to agree on its position on the proposal for a regulation on packaging and packaging waste on 18 December. Inter-institutional negotiations with the European Parliament on the final version of the law will then start.

Competition – Article 102 TFEU

The European Commission plans to launch a public consultation by mid-2024 on new guidelines on exclusionary abuses, which will be based on EU Courts case law and the Commission practice. The aim is to adopt them in 2025.
