# Law

#### Euro 7

The Council formally adopted the Euro 7 regulation, which lays down rules on emission limits for road vehicles and battery durability. This is the last step in the decision-making procedure. The legislative act will soon be published in the EU Official Journal and will enter into force on the twentieth day following its publication.

Regulation on type-approval of motor vehicles and engines and of systems, components and separate technical units intended for such vehicles, with respect to their emissions and battery durability

### **Energy Performance of Buildings**

The Council formally adopted the revised directive on the energy performance of buildings, which will be published in the EU Official Journal in the coming weeks. Member States will then have two years to transpose the new rules into their national legislation.

### **Digital Services Act**

The EC sent a request for information to TikTok under the DSA to obtain more details on the risk assessment that the platform should have carried out before rolling out its new "TikTok Lite" application in France and Spain.

### **Data Protection**

The European Parliament adopted its position on the proposal on additional procedural rules of the application of the General Data Protection Regulation. Inter-institutional negotiations with the Council on the final shape of the law will start after the European elections.

The EU requested consultations with the UK under the dispute settlement mechanism of the EU-UK Trade and Cooperation Agreement regarding the UK's decision to prohibit the fishing of sandeel.

The EC is collecting feedback on its draft implementing regulation which will set out the indicators for EU Member States to report on the application of the General Product Safety Regulation. Contributions can be submitted until 16 April. The adoption is planned for the second quarter of the year.
