■ Work Programme

The EC adopted its 2020 Work Programme with the initiatives that it will take in the coming months. Among the forty three new policy objectives there are proposals for a new European Data Strategy, a new Industrial Strategy for Europe, a new Digital Services Act to reinforce the single market for digital services, a European Climate Law to achieve the 2050 carbon neutrality goal. Together with the Communication the Commission published other documents: a list of new initiatives (annex I), a list of priority pending proposals (annex III), a list of initiatives to be withdrawn (annex IV) and a list of envisaged repeals (annex V).

■ 5G Networks

The EC calls on Member States to take by the end of April the necessary steps to implement the set of measures recommended in the 5G toolbox conclusions to address security risks related to the rollout of the fifth-generation of mobile networks and to prepare a joint report on their implementation by June 30th.

■ Brexit

The Council formally adopted the decision on the conclusion of the Withdrawal Agreement of the UK, following the vote of consent of the European Parliament. As of February 1st, the UK will no longer be a member of the European Union; however, until the end of the year the UK will continue to apply the European law. This transition period can be extended

for a period of up to one or two years if both the EU and the UK agree to that before July 1st.

■ Industrial Strategy

The European Commission is expected to launch a new Industrial Strategy by the end of March. The strategy will contain a series of comprehensive actions and initiatives to boost the industrial sector; special attention will be dedicated to the next-generation mobile technologies (to go beyond the 5G), to new data-sharing rules (with the revision of competition rules), to the introduction of new standards, to data cloud infrastructure, internet of things and robotics. The Commission intends to work on an appropriate legal framework for the entire online ecosystem, taking into consideration the growing importance of data economy.

■ Online Platforms

The European Commission's Vice President for Values and Transparency said that a regulation on the

activities of online platforms is needed in order to foster transparency and make platforms more accountable.

Solvency II

The European Commission will begin the review of the Solvency II Directive in the second half of the year, on the basis of the advice that the European Insurance and Occupational Pensions Authority will give by the end of June. Special focus will be dedicated on how to secure an adequate level of protection for policyholders while avoiding risks for financial stability.
