■ EU Strategic Agenda

EU Heads of State and Government adopted a new Strategic Agenda for the years 2019-2024. The document provides an overall framework with the priorities for the EU Institutions in the coming years. In particular, it focuses on four main issues: developing a strong economic base; promoting European interests on the global stage; building a green, fair and social Europe; protecting citizens and freedoms.

■ National Energy and Climate Plans

The EC published its assessment of EU Member States' Integrated national energy and climate plans (NECPs), with which each country will implement the Energy Union objectives, in particular the 2030 energy and climate targets. In most cases the NECPs are

insufficient to achieve the targets. Member States have until the end of the year to finalise and adjust their plans.

■ Sustainable Finance

The EC published new guidelines on corporate climate-related information reporting, as part of its Sustainable Finance Action Plan. They will supplement the existing guidelines on non-financial reporting and will be used by around six thousand EU-listed companies, banks and insurers that have to disclose non-financial information under the Non-Financial Reporting Directive.

■ ■ Technical Expert Group on Sustainable Finance

The Technical Expert Group on Sustainable Finance, the group set up by the European Commission to assist it in developing its Sustainable Finance Action Plan, published a series of reports: the first is a classification system for environmentally-sustainable economic activities; the second is a report on EU Green Bond Standards, then the third report on EU climate benchmarks and benchmarks' ESG disclosures. These reports will become the basis for the development of new regulatory frameworks for the financial sector.

■ Emissions Testing

The EC presented a proposal to reinsert certain aspects of Real Driving Emissions testing (RDE) into

legislation to be adopted by the European Parliament and Council. Once adopted by the two co-legislators, the regulation will be directly applicable in all Member States. Last December the General Court annulled some of the provisions of EU legislation on Real Driving Emissions testing. The text will be available soon.

■ EU Summit

EU leaders remained divided on the distribution of key posts, in particular on the EU's top jobs of Presidents of the European Commission, European Council, European Parliament and European Central Bank. EU Heads of State and Government will meet next Sunday (June 30th) with the aim to reach an agreement on the new nominees. In the meanwhile, consultations in Brussels will continue.

■ Multiannual Financial Framework

The European Council will discuss and exchange views on the new MFF package in October, with the aim of reaching an agreement before the end of the year.

■ Euro

EU Finance Ministers failed to agree on a Eurozone budget. Discussions will continue at the technical level, with the intention of reaching an agreement before the Multiannual Financial Framework is closed.
